

## Privacy policy

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. ## Personal information we collect

We may collect and process the following data about you:

### Information you give us

You may give us information about you by filling in forms on our website or by corresponding with us by phone, email or social media. The information you give us may include your name, address, email address and phone number.

### Information we collect about you

With regard to each of your visits to our site we may automatically collect the following information:

- technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- information about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.

We may also obtain information about you that is in the public domain, for example contact details presented on the websites of potential customers.

## Information we receive from other sources.

We work with third parties such as business partners, sub-contractors, advertising networks and analytics providers and may receive information about you from them.

## How we use personal information

We do not sell personal information.

Depending on how you engage with us, we may use your information:

- to deliver agreed products and services to you;
- to facilitate your use of this website and the services available through it
- for internal accounting and regulatory purposes;
- for statistical analysis to assess our business performance and to improve our products and services;
- to keep you informed about our products and services you might be interested in;

## Legal bases

Our legal bases for processing your personal information are:

- consent you have given
- processing necessary for the performance of a contract with you or to take steps to enter into a contract.

## Disclosures

We may share your information with selected third parties including:

- Business partners, suppliers and subcontractors for the performance of any contract we enter into with them or you.
- Analytics and search engine providers that assist us in the improvement and optimisation of our site.

### **We may disclose your personal information to third parties:**

- If Gigasoft Data Protection Limited or substantially all of its assets are acquired by a third party, in which case personal data held by it will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or to protect the rights, property, or safety of Gigasoft Data Protection Limited, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

## Where we store your personal data

The data that we collect will not be transferred to, or stored at, destinations outside the European Economic Area ("EEA"). It may also be processed by staff who work for us or for one of our suppliers. Such staff may be engaged in, among other things, the fulfilment of our contract, the processing of your payment details and the provision of support services. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

Where we have given you (or where you have chosen) a password, you are responsible for keeping this password confidential. We ask you not to share a password with anyone. Once we have received your information, we will use strict procedures and security features to prevent unauthorised access.

We endeavour to take all reasonable steps to protect the personal information we hold. All the data collected by us is stored using reputable software service providers.
